## INVESTMENT OBJECTIVE AND STRATEGY

The fund seeks to provide preservation of capital, liquidity, and, consistent with these objectives, the highest level of income exempt from federal and California state income taxes.

Invests at least 65% of total assets in California municipal securities, and at least 80% of the income is expected to be exempt from federal and California state income taxes.

## BENEFITS AND RISKS

Offers investors stability of principal, liquidity, and double-tax-free income.

Seeks to maintain a stable net asset value and provide an appropriate place for money between investments or during uncertain market conditions.

Some income may be subject to the federal alternative minimum tax.

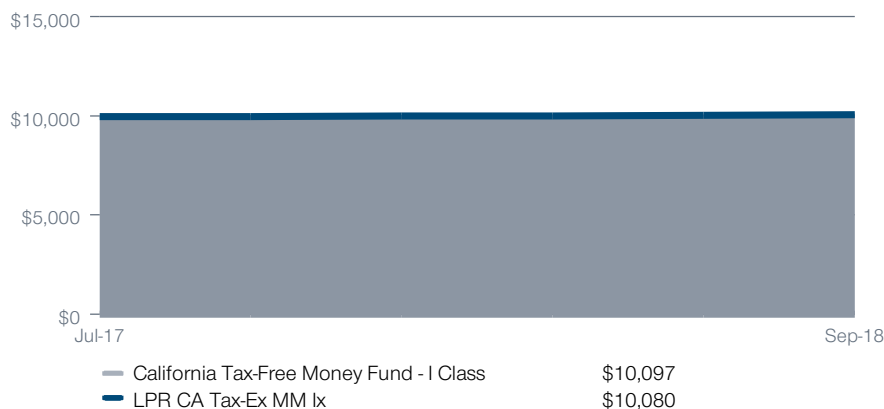
