Invests in high-quality, short-term securities with maturities of 13 months or less.

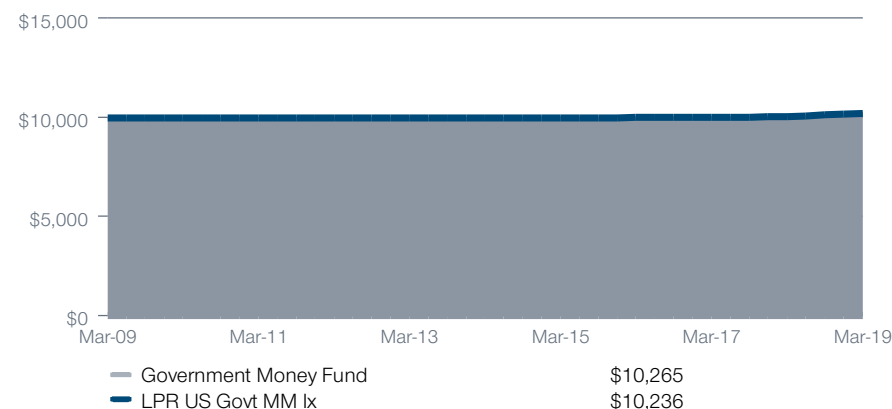
BENEFITS AND RISKS
